Narrative

NARRATIVE:

I, Zach Brunner, am a commissioned Deputy Sheriff with the Chelan County Sheriff's Office (CCSO). At the time of this incident I was assigned to the patrol division. I worked the night shift in the Valley, patrolled in full uniform, and drove a marked patrol vehicle.

The following report is a summary of an incident which occurred in the county of Chelan in the state of Washington (WA). This report also serves as a summary of my involvement in said incident.

Furthermore, portions of my involvement were recorded by my assigned patrol vehicles WatchGuard recording system. This system included a dash camera, back seat camera, and a body worn (audio only) recording device. I recommend having all incident videos transcribed. Please review any and all recordings related to this case for exact statements made, chronological order of events, and/or for further information outside of this report.

On July 4, 2024 at approximately 1711 hours Rivercom Dispatch received a call from [REDACTED] at [REDACTED]. This call to Rivercom generated CCSO Harass/Threat case 24C06401 at 7599 Colockum Road in Malaga. [REDACTED] reported he and Mountain Highway Towing assisted a male and female stuck up in the hills on a previous call (CCSO ATL 24C06391). Now, the subject was yelling he is going to get guns and come back to shoot since he cannot afford the bill. The suspect was identified as Ryan M Hell (1/9/78).

Please review CCSO ATL 24C06391 for further information about this case.

I responded to this incident with CCSO Sgt. Musgrove. I started by placing a phone call to [REDACTED]. I identified myself and advised [REDACTED] of my audio/video recorder.

To summarize my understanding of my conversation with [REDACTED] At the time of this incident, [REDACTED] worked for Rivercom but was off duty and was also a volunteer firefighter.

[REDACTED] provided the license plate of Ryan's truck, C63884Y. This truck returned to a 2007 Ford F150 registered to Ryan.

Ryan had been stranded last night up on Colockum Pass, so [REDACTED] went and picked him up. A tow truck also picked up Ryan's truck and brought it back to [REDACTED] residence. [REDACTED] claimed he told Ryan how the bill was going to be between him and the tow company. Ryan had an issue with the bill, which was \$1000 dollars. The tow company wasn't going to turn over the keys until they were paid. Ryan seemed to believe [REDACTED] lured him into a scam. [REDACTED] alleged that Ryan threatened him, saying how once he left here he would go get guns and come back start shooting. Ryan was also still in [REDACTED] driveway at the time of our call, amped up.

Initially, it did not appear [REDACTED] wanted to have Ryan arrested. He wanted Ryan gone, didn't want to worry about him coming back, and wanted this incident documented. At the time of our first call, [REDACTED] also hadn't seen any weapons at this point.

I had brought up with [REDACTED] if the tow company could figure out an alternative. To get the truck and/or Ryan out of there, to negotiate the civil

matter elsewhere.

██████ called me back around 1731 hours. He advised Ryan wanted no part of the compromise with the tow company and that he was going to stay there and drag it out. He also was going to wait until we get there. I asked if Ryan was going to be orderly until we get there. ██████ explained how he hasn't been physical at all, but he wouldn't quit talking long enough to listen to anybody.

I kept Sgt. Musgrove informed as this incident evolved. Sgt. Musgrove and I continued to the residence with a routine response until ██████ called back to Rivercom at approximately 1934 hours, reporting Ryan had pulled a knife and asked law enforcement to step it up. ██████ had also described the knife to Rivercom as being a 4-5 inch folding buck knife on his right hip.

Sgt. Musgrove and I then responded to the incident with our emergency equipment activated.

While we were enroute, Ryan, also called Rivercom from a 911 only phone. He claimed things such as how he was homeless and didn't have \$1000 to pay the tow bill. He claimed he is being targeted and victimized.

Please review the CAD comments in Spillman and/or the 911 call recordings for further information.

WA Fish and Wildlife Officer WL 133 was also in the area and inquired if we wanted assistance which we accepted. He responded to assist us with this incident.

Once we all arrived in the area we conducted a pre-plan and assigned roles. We planned to conduct a "pace" stop. I was also assigned the role of contact as well as taking possession of and readying my less than lethal shotgun.

At approximately 1802 hours we arrived in the area and observed Ryan walking in the roadway. I activated my overhead emergency lights. I advised Ryan he was being detained and provided a force warning. We provided Ryan instruction and he was secured in handcuffs by Sgt. Musgrove. Sgt. Musgrove would pat searched Ryan and remove a black folding knife and a Leatherman multi. Sgt. Musgrove talked with Ryan about this incident.

I stood by with Ryan with WL 133 while Sgt Musgrove went to the incident location and contacted those on scene. Ryan talked at length. Simply put, Ryan denied making the threats involving firearms and also denied the allegation of him threatening others with a knife.

Sgt. Musgrove returned, talked with Ryan briefly, and advised Ryan he was under arrest.

I searched Ryan incident to arrest and secured him in my patrol vehicle. I readjusted his handcuffs, which I double locked and checked for proper fit. I transported Ryan to the Chelan County Regional Justice Center (CCRJC) and arrived at approximately 1856 hours. Ryan had complained about the handcuffs, so I photographed his wrists and advised Sgt. Musgrove.

Sgt Musgrove had advised me Ryan was to be charged with three counts of the felony harassment threats to kill. He also advised to trespass Ryan from the location.

I completed a Chelan County Superior Court Warrantless against Ryan for three

counts of RCW 9A.46.020.2bii Felony Harassment Threats to Kill.

During my interactions with Ryan I took notice of how at times he appeared to be paranoid and had rapid speech. He seemed to believe things such as how people were after him and wanted to kill him.

Sgt. Musgrove obtained a signed written statement from [REDACTED] (REDACTED). Although I will transcribe these statement in my narrative to the best of my ability, please review their written statement as a part of your review of this case.

"Mid day on 7-4-24 I learned of a stranded motorist on Colockum Pass Rd, which is not far from my residence. I went to help the stranded motorists as one of them was diabetic and was not feeling well. Upon arrival, the male and female both looked very hot, and the female was not feeling well. I told both of them who I was and that I was a volunteer firefighter and was offering to take them back to my place, out of the heat, to wait for the tow company that had been called. Both the male and female were very appreciative for the help. We loaded everyone into my personal vehicle and returned to my house, including their 2 dogs. We sat in my shop and waited for the tow company. At one point prior to returning to my place, the male tried to give me money, which I refused, stating the reason I was helping was to get them out of the heat, and the females diabetic issues, which were resolved with orange juice and some candy. Approximately 1.5 hours after arriving at my place, the tow company returned with their truck, having replaced a flat tire and driving it out for them. I was in the shop and walked outside where the male half was talking with the tow company. He then said that we were trying to scam him as he walked up and got in my face, accusing me of tricking him into a scam. He became more irate, and then stated that he was going to leave and get guns, come back and shoot the place up. This is when I called Rivercom and asked LE to step it up, as they were already enroute. The male continued to yell and accuse me of impersonating a city employee and yelling obenities. He began calling my wife names. I told him he needed to calm down, and he reacted by peeling his vest off and pulled a folding knife off his hip, opened it, and stood in a stance ready to fight. I called Rivercom again and stayed on the line until LE was out with the male."

Sgt. Musgrove obtained a signed written statements from [REDACTED] (REDACTED). Although I will transcribe these statement in my narrative to the best of my ability, please review their written statement as a part of your review of this case.

"I Drove with my Husband Jeremiah to help out some people that were in Need of Help as we got there a lady and a man was there I then gave the woman some water due to She was the one that needed help more. Apond Notice there truck had a flat tire and riding on rims, the man said that he would pay us for the ride down till a tow truck came and got the truck we told him that was not needed just pay our part forward then we told him that he need to take up pay for tow with them, everything was fine till tow pick up truck and they told him he needed to money for the tow, they talked for a few then the man got into my husbands face and told him that some one was going to get hurt and shot if they take his truck, after that I started to recored and then he pulled a knife and got that on viedo as well, He began taking crap to me so I got a little mouthy. he was all over the board. With threatening [REDACTED] [REDACTED]"

Sgt. Musgrove obtained a signed written statement from [REDACTED] (REDACTED). Although I will transcribe these statement in my narrative to the best of my ability, please review their written statement as a part of your review of this

case.

"Rivercom called mountain highway towing for a couple stuck in the mountains up clockum pass so we got our 5x5 loaded Rivercom stated they had multiple flats and had been there over night and that the males gf had a diabetic issue going on so we bought 2 rims & tires for the truck and brought water and snacks for the gf to bring her levels back up one of the Wenatchee volunteer fire fighters went up and got the male & female so we unloaded the side by side at his house and went up to get the truck out of the mountains once done we got back and gave the customer the bill at that point he said he wasn't going to pay and told us if we touched his truck he was going to shoot us then walked over the volunteer and yelled at him and his wife multiple times saying we where all radicals he got into our faces a couple times then got more irate and pulled off his vest and pulled a knife and began threatening everyone some more till eventually he walked down the driveway."

Sgt. Musgrove obtained a signed written statement from [REDACTED] ([REDACTED]). Although I will transcribe these statement in my narrative to the best of my ability, please review their written statement as a part of your review of this case.

"Came out to Malaga to assist with getting a truck that was disabled up in an area known as the clockum we assisted the stranded motorist per Rivercoms request when we got to the customer/stranded motorist and got the truck to a safe location we let him know that the bill was around \$1000 dollars he became very upset said he didn't have that kind of money said we would have to take his truck I said we will have to figure something out because the bill is 342.90 per hour plus the cost of the tire and he said well you will take a bullet before you take my truck we tried offering alternative solutions so he could drive his truck home such as just paying us for the tire we put or putting air in his tire that he said was just flat but after he became upset there was no reasoning with him we all stood around while waiting for officers to arrive and listened to his volger language while he made threats to call people and shoot up the place and said he would come back after he got out of jail he called us all names said after me he was done with us we would all loose our jobs and kept saying we don't know who he is and what he is capable of and who his family is."

I also learned portions of this incident were captured on video and that Sgt. Musgrove observed a portion of this video, which captured a portion of the incident with the knife. Further investigation to follow to retrieve this video evidence.

I completed SECTOR Warning W24062860 against Ryan, to inform him he is trespassed from 7599 Colockum Road and if he returned he would be arrested. I emailed this to the jail booking officer and requested they place this in his jail property.


